## ■ Editorial

Welcome to the second edition of the *ITIA Bulletin*. Since its launch last month the number of subscribers has soared. There are now over 740 people from every corner of the world reading the Bulletin. With such a varied readership it would be great to see this diversity reflected in the Bulletin. The *ITIA Bulletin* is a forum for all translators and interpreters everywhere so please feel free to submit articles or let us know of any interesting news or developments.

On a more practical note, I received an email from one of our members, **Crispin Welby**, which raises the age old problem of whether to charge for the number of words in the *source* text or for the number of words in the *target* text. Some clients prefer source rates because it means they know the exact cost before work starts. But bear in mind that with some language pairs, you will actually *lose money* by basing your rates on the source text because the wordcount can expand in the target text by anything up to 25%. So unless you increase your rates accordingly, you are giving clients what are frequently massive discounts.

In Crispin's case, a client wrongly assumed that the rate for a job was based on the source wordcount. In the interest of good business relations, Crispin accepted the source wordcount even though this meant losing money. It was agreed, however, that a higher source rate would apply to all future business.

The key to avoiding this type of problem is communication. The message from Crispin is always specify whether your rates are based on SOURCE or TARGET wordcounts.

translator's name should be his or her guarantee of the quality of a translation. The intention of this provision is not simply to give good translators the attention they deserve, but also to make less well qualified and less conscientious competitors more aware of their own responsibility, ultimately benefiting publishers and the reading public alike.

Another aspect of copyright is the right of integrity. While translators cannot oppose editorial revisions undertaken by a principal in agreement with the author, translators' texts are often 'revised' at will by people in no way better qualified than the translator. As copyright holders, translators are entitled by law to expect others to respect their rights, i.e. no one is entitled to randomly correct or edit a translator's work without his or

her approval. This means that when an editor makes incorrect revisions in a translator's text, then publishes the translation under the translator's name, both the moral aspects of copyright have been infringed. Likely as not, that editor has broken the law! What is more, these immaterial rights are inalienable. We cannot get rid of them, no matter how hard we try. Enforcement is another matter. That is one of the reasons translators' associations and FIT are so important.

**Material rights:** What are the financial implications of copyright? When someone photocopies a text or downloads it onto a PC, that user deprives all those holding copyrights in the work (author, translator, photographer, etc.) of income they might have had from the sale of the work. The same applies when a user borrows a book from a library. In both cases, the user reads the book, but the rightholders do not necessarily reap any financial fruits of their own labours. Accordingly, the financial benefits of copyright are based on (1) remuneration for reprographic reproduction (photocopying and, hopefully in the not too distant future, digital copying) and (2) the Public Lending Right (PLR), a small fee paid by library owners (often the authorities) for depriving rightholders of income by lending out their works free of charge.

## ■ Copyright - 50 years on

Copyright was one of the main issues that brought translators associations together to form FIT in 1953. Fifty years on, it continues to be a rallying point in the struggle for translators' rights.

Copyright is first and foremost the right to reap the fruits of one's labours.

Copyright in translation embraces both immaterial and material rights.

**Immaterial rights:** Please take a few moments to review one of FIT's most fundamental documents, "The Translator's Charter" (<http://www.fit-ift.org/english/charter.html>). Based largely on the Berne Convention for the Protection of Literary and Artistic Works (<http://www.wipo.int/treaties/ip/berne/>), which covers 90 per cent of the global population, the Charter stipulates that a translator's name shall be published each and every time his or her translation is presented to the public. This 'moral' aspect of copyright is called the right of attribution or paternity. It applies not only to literary, but also to technical and scientific translations. A

Where do the associations come in? Rightsholders' associations, including translators' associations, face tremendous challenges in this context. It is essential that translators be included in national copyright legislation. The associations also need to monitor closely the national progress of photocopying and PLR issues, not least in terms of precedent law. Associations would be well-advised to support their members in connection with copyright infringement cases. They should also try to ensure they are on any and all hearing lists related to copyright legislation so they know what is going on and can have a say before laws are adopted. The most important message in this context may be 'Strength in numbers'. Contact other rightsholders' associations in your country and try to find ways in which to co-operate on these issues.

Most countries have legislation that protects the rights of creators. For links to copious volumes of information on the subject of copyright, please follow the links posted on the FIT Copyright Committee website (<http://www.fit-ift.org/english/copyr.html>). Perhaps the single most important thing associations can do is to educate their officers, then their members. Recruitment is important. The larger the percentage of organized translators, the greater their chances of obtaining standard contracts that specify translators' rights. Interpreters have rights that are related to copyright, but covered under performance rights conventions. Interpreters should be aware that they are not required to interpret into multiple microphones if not contracted to do so in advance.

Do the same laws apply in all countries? No, different countries have different systems for dealing with copyright. Your association needs to find out exactly which systems apply in your country, and to determine their implications for translators. Many countries have reproduction rights organizations which collect remuneration on behalf of rightsholders. FIT is an associate member of IFRRO, the International Federation of Reproduction Rights Organizations (<http://www.ifrro.org/>). Check the IFRRO website to learn more about collecting societies and to see whether your country has one. Fifteen countries now have Public Lending Rights. For a list of the countries with PLR and more detailed information, see (<http://www.plrinternational.com/>). The authorities are usually the rightsholders' counterpart insofar as PLR is concerned.

Where does the money generated by copyrights go? In some countries, the money derived from photocopying and/or PLR is paid out as individual remuneration.

Others, like the Nordic countries, apply what is known as an 'extended collective licence' (see <http://www.kopinor.no/english/ext-eng.html>). Unfortunately, the translation contracts used in many countries entail that all financial benefits derived from copyright go to the publisher or another principal. It is up to our associations to address this issue at the national level and to make every effort to ensure that translators, individually or collectively, share in the financial benefits of copyright. No one can do this for you. It is up to the associations themselves to take stock of the situation and identify potential sources of copyright revenues for translators.

Leading up to the *FIT Copyright Conference November 2003*: FIT invites its members to examine the copyright legislation in their home countries. Review the legal precedents being set. Work within your association or with other rightsholders' associations to determine exactly what your rights are and how you can best exercise and defend them. Although copyright is covered by international conventions, it is up to individual nation-states to adopt and enact the various provisions.

It is critical to defend translators' rights at this juncture. While the advent of the Internet has been a boon to translators, it also leaves us wide open to mass copying and the digital distribution of our works. What is more, unless we put in place and enforce copyright protection now, products such as translation memory threaten to divide our utterances up into such small segments in

databases that we will have no hope of defending our rights in the future.

The copyright situation is different in every country. FIT urges you to join forces with similar groups of rightsholders in your country to examine the options open to you.

**Suggestions:** Organize a national copyright event that brings together all rightsholders or their representatives. Meet with your national collecting society. Invite experts to speak on copyright in translation on ITD. Contact other rightsholders' associations in your home country and examine the issues together. Contact sister organizations in other countries to find out about their situations, and then send a representative to the Copyright Conference FIT will be organizing in Paris on 21 November 2003 in conjunction with FIT's 50th Anniversary celebration on 22 November 2003 to learn more about copyright!

## ■ Reorganisation of EU Translation Service

### Commission approves major reorganisation of its Translation Service to increase effectiveness and prepare for European enlargement

The European Commission has approved a major reorganisation of its Translation Service, on a proposal by Vice-President for Reform Neil Kinnock. The main objectives are to refocus activities on the Commission's core business, increase productivity and effectiveness and introduce the translation capacity required for the new languages resulting from the next enlargement. The Service will be based around two 'Language' Directorates (in Luxembourg & in Brussels) carrying out the translation work itself, and a Resources Directorate to provide horizontal support and management.

The Language Directorate in Luxembourg will be responsible for translation into the languages of the future Member States, as well as German and Dutch. The Brussels-based Directorate will deal with the other languages. The Resources Directorate will increase its focus on sound financial management, set up a central system of contracts with freelance translators and manage the requests and deadlines for freelance translation.

All told, the reorganisation will lead to the progressive creation of 460 posts in Luxembourg, thus contributing to the Commission's aim of consolidating its presence in this Member State. The reorganisation will be effective as of 1<sup>st</sup> July 2003. The Translation Service becomes the Directorate-General for Translation.

## ■ International Literary Translation Centre in Canada

A new international literary translation centre has been established at *The Banff Centre*, in the Canadian Rockies.

Just over a year ago, Peter Bush from the British Centre for Literary Translation and Claude Bleton from CITL in Arles, attended an exploratory colloquium, organised to study the feasibility of setting up the first North American centre in Banff. The colloquium resulted in unanimous support for the creation of the *Banff International Literary Translation Centre (BILTC)*.

The centre will be truly North American in that programming and adjudication will be overseen by an advisory board composed of literary translators representing associations from Canada, Mexico and the United States. The programme at BILTC will begin with a first residency of three weeks, running from 17<sup>th</sup> August - September 2003. The residency programme is open to translators from Canada, Mexico and the United States, translating from any language. The programme is also open to international translators translating literature from the Americas. Applications to the International Literary Translation Centre must be submitted by 31<sup>st</sup> March.

## ■ Translators to face the balka?

It seems that despite the 10-point plan, which I outlined in the last issue to raise the profile of translators and interpreters we're all doomed! Those clever eggs at *HewlettPackard* have come up with something that could conceivably see translation becoming a thing of the past, something to be looked back on fondly and studied in much the same way as scholars study Sanskrit. How you might ask? Well, what do you get if you cross English, Japanese and Esperanto? You get a hybrid, manufactured language called *Computer Pidgin Language*, CPL for short.

Tired and frustrated at the apparent lack of progress being made in the field of voice recognition, the boffins at *HP Laboratories Bristol* decided that rather than trying to bend computers to the will of their masters, it would make much more sense to get humans to adapt to the capabilities of computers. They examined various different languages - both natural and artificial - to see where computers scored best at voice recognition and where they ran into problems. Taking those phonemes from each language which computers found easiest to "understand" they transposed these rudimentary sounds onto an entirely new lexical and grammatical framework to form the basis for a new, albeit simple language which computers could understand with a great deal of reliability and which humans could learn with minimum effort.

According to the HP white paper which describes CPL, "This is a radical new approach to dealing with the problem of humans talking to computers. The new approach is to teach people a new language that is efficient for dialogues with computers - a sort of artificial spoken language. They go on to say that CPL

could conceivably become a cyber-latin or lingua franca of the Internet.

Sounds great doesn't it? Well it is until you hear what it sounds like. Printer becomes "*crinter*" while telephone becomes "*teleter*". Some expressions are particularly easy for computers to understand and these can be given any meaning you want. So you can say "*balka*", "*coupo*", "*obobify*" or "*okilimox*" and mean practically anything you want.

In designing CPL, the researchers were keen to make it as simple as possible. With this in mind they decided that:

- ◆ Only one diphthong is allowed per word. Diphthongs are: 'ey', 'ay', 'oy', 'ow', 'aw'.
- ◆ Short vowels are not allowed at the end of words. Short vowels are 'aa', 'ao', 'ih', 'eh', 'ae', 'ah', 'uh' and 'aw'.
- ◆ The phones *zh* and *th* are not used
- ◆ The phone *ng* is not a valid starting consonant.
- ◆ The phones *r*, *y* and *w* are not allowed either side of a diphthong.
- ◆ The phone *hh* is not allowed as a second consonant.

With a limited vocabulary and simplified pronunciation rules, it shouldn't be too hard to learn CPL. But kids and teenagers will apparently find it the easiest to learn. Now it's bad enough that they listen to manufactured music but now they'll all be speaking a manufactured language and us old fogies over the age of 20 will need interpreters to understand them when they speak to us. That's if they even bother speaking to us. I mean, if we don't speak CPL we're obviously nowhere near cool enough to merit our existence being acknowledged by them.

What's more, if CPL does become the language of the Internet, will we still need to localise websites? What if CPL breaks out of cyberspace and makes it into the real world? Could we see the end of natural languages and of translation as we know it? Probably not. But then again, stranger things have happened. More than likely it will be the kids who speak CPL. So maybe the future isn't so bleak for translators and interpreters after all. Admittedly, the landscape for translation could change radically with everything being translated into or out of CPL but parents will always need to talk to their kids.

One thing is for certain, though, if this does catch on it won't matter how *coupo* kids may find it, it'll be a pain in the *okilimox* for the rest of us!
