The International Federation of Translators (FIT) has set the theme for celebrations worldwide, challenging member associations to “imagine just one day without translation”. Translators are vital to exchanges between nations and individuals. Many of our most cherished beliefs, legal rights and mental structures – even some of our worst fears – have come to us through translation. In a world of misunderstanding, translators bridge the gap.

The ITIA plans to dramatize this theme with a brief recital of texts in a variety of languages – Polish, German, Irish, Italian and others, even including English – and with a short humorous reflection on THE JOY OF MISUNDERSTANDING. ■ The Second Dublin City University International Postgraduate Conference in Translation Studies

Following the huge success of the first DCU International Postgraduate Translation Studies Conference in 2004, the second conference will be held on April 1st and 2nd 2005 and again is open to all young researchers doing work in translation studies. The conference is open to:

Delegates are invited to submit abstracts from all areas relating to translation studies, including fields such as contrastive linguistics, terminography and lexicography, translation and gender, literary translation, translation theory, translation technologies, interpreting studies, localization, audiovisual translation, Bible and religious translation, translator and interpreter training, history of translation, corpus-based translation studies, translation and cultural studies, translation and human rights, etc.

Papers should be no longer than 20 minutes, and will be followed by 10 minutes of questions. Abstracts should be submitted to John Kearns (kearns(a)pro.onet.pl) by January 15th 2005.

There will be several established translation studies scholars and guest speakers in attendance to provide feedback and advice to delegates. Delegates will also have reference access to the extensive collection of Translation Studies literature in DCU Library for the duration of the conference.

Ethics and the Social Value of Translation

Eighteenth Annual Conference of the Canadian Association for Translation Studies

University of Western Ontario, London, May 2005

Translators' (and interpreters') ethics and the social role of translation (and interpretation) are a source of interest and concern for translation scholars. While ethics may be the art of conducting oneself with respect to oneself and others, it is comparatively more relevant for translators because it touches on several aspects of their work. Historically, faithfulness has been used to assess the quality of translators' work as much as their social role. Faithfulness is then assessed regarding the author the translator is representing; then regarding the readership the translator is representing; finally, with respect to translation as a profession and to the rules that govern it. However, there is much more to ethics than the single issue of faithfulness.

According to Anthony Pym, the translator's ethics concerns first and foremost the way in which the translator establishes the social and intercultural relationships that determine his or her practice. Therefore, the translator is a responsible professional whose duty it is to carry out an intercultural mission of co-operation. For Antoine Berman, ethics tends to affirm and defend the aim of the translation and to define the idea of "faithfulness." What he suggests is an ethics aimed at openness, dialogue and merging the Self and the Other, instead of promoting a reductionist, appropriating and ethnocentric approach.

Furthermore, any professional rule established at any given time can only be seen as part of deontology, which is different from ethics while being closely related to it.

It is these parameters and the rules imposed upon translators by society and the profession that put them in the position of having to make choices (the first one being whether or not to translate) which will affect the reader's perception of the author and the translated text, the author's perception of the translator and the reader, but also, and maybe most of all, the translator's perception of the author and the reader.

Supported or hindered by these parameters, translators cannot ignore their role as agents of social change. If ethics focuses on the practice of translation, on the dialogue with the Other, on social accountability and intercultural co-operation, it also calls upon translators' moral duty and should lead them to personal and professional fulfilment. Therefore, one can ask the following questions:

Are ethics and social duty compatible? Is the ethics of translation the same as ethics of intercultural communication? Is it possible to echo what Pym wrote and affirm that there is a clear demarcation between deontology and the ethics of the translator?

These questions can also be considered from the point of view of many fields of study: feminism, post-colonialism, queer power, multiculturalism and social integration, preservation of national identities, theories of translation, history, teaching and assessment of translating competence (*savoir-être*).

Meta Conference: "For a Proactive Translatology" April 7-9, 2005 University of Montreal, Quebec, Canada

Researchers and practitioners are invited to submit proposals for this three-day international symposium organized and hosted by META to commemorate its 50th anniversary. Abstracts should ideally cover the area of proactive translation studies and research.

Over the last half century the translation market has undergone significant changes together with the emergence of theoretical and scientific studies of translation as a discipline. A pioneer and pathfinder among translation journals, Meta has gained and maintained its status and stature as an acknowledged reference in the field, thanks to the broad perspective it offers on approaches, both theoretical and practical, to translation, interpretation and terminology. In a sense, the history of Meta mirrors that of the profession and the discipline. Meta would like to seize this opportunity of its 50th anniversary to both look back and take stock as it looks ahead and prepares for the future.

As translology developed as a distinct discipline, the language market expanded exponentially creating new needs. To what extent have universities been able to meet these needs? What has been the impact of theoretical studies which have been rather extensive and outstanding on translation pedagogy and practice? Does research necessarily translate into practice? The gap, so often criticized, between research and practice does indeed exist. While proactive translology does not claim to bridge this gap, it seeks to be forward looking, to anticipate needs. Poised at the forefront of innovation, it stands ready to respond appropriately.

The organizers are hopeful that this symposium will at the very least strike a chord within the language community and serve as a stepping stone to more commitment, activism and thought-provoking contributions.

Submissions focusing on all proactive dimensions of translation studies are being sought:

The Discipline: Translation Studies has always been defined in terms of its inter-disciplinarity. Should attempts be made to lessen the cleavages in the discipline or should diversified approaches - which are potential sources of enrichment - be encouraged? How could dissemination of research in related disciplines be promoted?

- ◆ The pedagogical context is evolving not in terms only of approaches and means but also of social change affecting successive generations of students. How can teaching strategies and program content be reshaped? What possibilities do new technologies offer in this area?
- ◆ Cultural and Political Dimensions: Discoursal practice implies social commitment. Can / should translology and terminology be considered in abstraction? How should this commitment be addressed?
- ◆ Terminology: Terminology is undergoing constant change. What should the theoretical frameworks for the study of specialized languages be? What is the role of the new approaches proposed over recent years, such as social-terminology, social cognitive, communicative or text-based approaches.
- ◆ New Technologies: As text editing tools and support, new technologies are crucial. How has research in this area impacted the profession? Does research respond to the real needs of language professionals? What are the possibilities for the future?

Presentations may be made in French, English or Spanish; however, the availability of interpretation services is not foreseen.

Abstracts of about 250 words should be submitted before December 1st, 2004 as Word attachments to the following address: meta(a)umontreal.ca. Authors are asked to indicate their name, address and professional affiliation and indicate any special needs (AV equipment) for their presentation. Selection will be completed and confirmed by January 20th, 2005. Meta will publish the proceedings of the symposium.
